### **Tarif for Space / Booth**

3. Minimum island area is 54 sq.m.
4. Two side open booth is 9sq. m./12sq.m/15sq.m.
5. US\$ 325/-plus18%GST (USD three hundred twenty five only) per sq.mtr. On shell scheme basis for foreign exhibitors.
6. INR 90,000/- plus18%GST(Rupees Ninety Thousand only) per 9 sq.mtr. on shell scheme basis for Indian exhibitors or in proportion there of.
7. 10% extra for two side open booths.
8. Discount @ 10% on published tariff on raw space without carpet & with electrical point for island only.
9. Booking for Booths will open on 1stAugust2023
10. Last day of booking booth is 17th August2023
11. Allotment of stalls shall be strictly start taking into consideration receipt of advance payment
12. **Complying With CDSCO/Drug Licensing Regulations Is Entirely The Responsibility Of Stall Holders/exhibitors.**
